Buenaventura Clarifies Details of Stock Split

Lima, Peru, July 8, 2008 - Compañía de Minas Buenaventura S.A.A. (the "Company" or "Buenaventura") (NYSE: BVN; Lima Stock Exchange: BUE.LM), Peru's largest, publicly-traded precious metals mining company clarifies the details of its two-for-one stock split announced Thursday, July 3, 2008.

The **correct** Record and Payment dates are as follows:

- The Record date is July 18, 2008.
- The ADR Payable date is July 22, 2008.

In addition, Buenaventura's stock will be reflected on a post split basis beginning on the morning of **July 23, 2008**. The Company apologizes for any confusion this may have caused.

Company Description

Compañía de Minas Buenaventura S.A.A. is Peru's largest, publicly-traded precious metals company and a major holder of mining rights in Peru. The Company is engaged in the mining, processing, development and exploration of gold and silver and other metals via wholly owned mines as well as through its participation in joint exploration projects.

Buenaventura currently operates several mines in Peru (Orcopampa, Uchucchacua, Antapite, Julcani, Recuperada and Caraveli) and also has controlling interests in two mining companies (CEDIMIN and El Brocal) as well as a minority interest in several other mining companies in Peru. The Company owns 43.65% in Minera Yanacocha S.R.L. (a partnership with Newmont Mining Corporation), an important precious metal producer, and 18.50% in Sociedad Minera Cerro Verde, an important Peruvian copper producer.
