**For Immediate Release****BUENAVENTURA AND RN GROUP AGREE TO EXPLORE SPAIN'S RIO NARCEA BELT**

**Lima Peru, March 16, 2005** - Compañía de Minas Buenaventura S.A.A. ("Buenaventura") (NYSE: BVN; Lima Stock Exchange: BUE.LM), Peru's largest publicly traded precious metals mining company today announced an agreement with RN Group to explore the Rio Narcea Belt in Spain.

Buenaventura has agreed to spend 2.2 million Euros in exploration during the first two years of operations, in exchange for a 51% stake of the Rio Narcea Belt and related properties. Buenaventura has the option of increasing this stake by another 19% for an additional 2.4 million Euros, during the a subsequent two-year period. Buenaventura will create a subsidiary, Minera Santa Marina del Norte S.L., as an investment vehicle for this project.

Mr. Roque Benavides, Chief Executive Officer, stated: "We are pleased to announce the agreement with Rio Narcea Gold Mines Ltd to explore the Santa Marina gold property located two kilometers north of the El Valle mine on the Rio Narcea Gold Belt. This transaction will contribute to Buenaventura's overall geographical diversification. The Company's environmental standards comply with those of the European Community, thereby facilitating our entry into this market."

Rio Narcea Group consists on Rio Narcea Gold Mines S.A, Narval Gold S.R.L and Rio Narcea Gold Mines Ltd.

**Company Description**

Compañía de Minas Buenaventura S.A.A. is Peru's largest, publicly-traded precious metals company and a major holder of mining rights in Peru. The Company is engaged in the mining, processing, development and exploration of gold and silver and other metals via wholly-owned mines as well as through its participation in joint exploration projects.

Buenaventura currently operates three mines in Peru and also has controlling interests in four mining companies as well as a minority interest in several other mining companies in Peru. The Company owns 43.65% in Minera Yanacocha S.R.L. (a partnership with Newmont Mining Corporation) and is one of the most important precious metal producers in the world.
