BUENAVENTURA ANOUNCES INCREASE OF OWNERSHIP IN CERRO VERDE

Lima, Peru, June 2, 2005 - Compañía de Minas Buenaventura S.A.A. (or "the Company") (NYSE: BVN; Lima Stock Exchange: BUE.LM), Peru's largest publicly traded precious metals mining company, today announced that the capital increase process in Sociedad Minera Cerro Verde S.A.A (Cerro Verde) was completed on June 1, 2005.

In the process of this capital increase, Buenaventura subscribed 42,925,975 shares increasing its participation from 9.17% to 18.214%.

This capital increase will partially finance the US\$850 million expansion project that will allow the mining of a primary sulfide ore body, starting at the end of 2006.

Mr. Roque Benavides, President and CEO, stated: "We are pleased to increase our participation in a company with such a good project led and operated by Phelps Dodge, as well as welcoming Sumitomo as a new partner in Cerro Verde".

Company Description

Compañía de Minas Buenaventura S.A.A. is Peru's largest, publicly-traded precious metals company and a major holder of mining rights in Peru. The Company is engaged in the mining, processing, development and exploration of gold and silver and other metals via wholly-owned mines as well as through its participation in joint exploration projects.

Buenaventura currently operates three mines in Peru and also has controlling interests in four mining companies as well as a minority interest in several other mining companies in Peru. The Company owns 43.65% in Minera Yanacocha S.R.L. (a partnership with Newmont Mining Corporation) and is one of the most important precious metal producers in the world.
