## Operations Resume at Buenaventura's Orcopampa Mine

**Lima Peru, June 8, 2012** -Compañia de Minas Buenaventura S.A.A. ("the Company" or "Buenaventura") (NYSE: BVN; Lima Stock Exchange: BUE.LM) announced today that the Company has reached an agreement with the Orcopampa workers' union within the frame of the annual collective negotiations.

As a consequence, the union concluded the strike that began May 26, 2012. Normal operations resumed at Orcopampa this morning.

It is important to mention that this strike was declared illegal by the Peruvian Ministry of Labor.

## **Company Description**

Compañía de Minas Buenaventura S.A.A. is Peru's largest, publiclytraded, Precious Metals Company and a major holder of mining rights in Peru. The Company is engaged in the mining, processing, development and exploration of gold and silver and other metals via wholly owned mines as well as through its participation in joint exploration projects.

Buenaventura currently operates several mines in Peru (Orcopampa\*, Poracota\*, Uchucchacua\*, Antapite\*, Julcani\*, Recuperada\*, El Brocal, La Zanja, Coimolache and CEDIMIN\*).

The Company owns 43.65% of Minera Yanacocha S.R.L (a partnership with Newmont Mining Corporation), an important precious metal producer; 19.35% of Sociedad Minera Cerro Verde, an important Peruvian copper producer, and 49% of Canteras del Hallazgo S.A, owner the Chucapaca project.
