**BUENAVENTURA ANNOUNCES RESULTS OF BOARD OF DIRECTOR'S MEETING**

**Lima, Peru, March 25, 2011** - Compañía de Minas Buenaventura S.A.A. ("Buenaventura") (NYSE: BVN; Lima Stock Exchange: BUE.LM), Peru's largest publicly-traded precious metals mining company announced today the results of the Company's Board of Directors' Meeting held March 25, 2011. The following resolutions were passed:

1. The election of Mr. Roque Benavides as Chairman of the Board, maintaining his current position of President and Chief Executive Officer.
2. The election of Mr. Felipe Ortiz-de-Zevallos as Lead Director and President of the Corporate Governance Committee. This Committee is composed of the following Independent Board Members: Messrs. Luis Coleridge, Carlos del-Solar, Felipe Ortiz-de-Zevallos, Aubrey Paverd, Timothy Snider and German Suarez.
3. The election of Mr. Luis Coleridge as President of the Audit Committee. This Committee is composed of the following Independent Board Members: Messrs. Luis Coleridge, Felipe Ortiz-de-Zevallos and German Suarez.
4. The election of Mr. Felipe Ortiz-de-Zevallos as President of the Compensation Committee. This Committee is composed of the following Independent Board Members: Messrs. Carlos del-Solar, Felipe Ortiz-de-Zevallos and German Suarez.
5. The Nominating Committee is composed of all Board of Director Members and will be chaired by Mr. Roque Benavides.



Compañía de Minas Buenaventura S.A.A. is Peru's largest, publicly-traded precious metals company and a major holder of mining rights in Peru. The Company is engaged in the mining, processing, development and exploration of gold and silver and other metals via wholly owned mines as well as through its participation in joint exploration projects.

Buenaventura currently operates several mines in Peru (Orcopampa, Uchucchacua, Antapite, Julcani, Recuperada and Caraveli), has controlling interest in two mining companies (CEDIMIN and El Brocal), as well as a minority interest in several other mining companies in Peru. The Company owns 43.65% in Minera Yanacocha S.R.L. (a partnership with Newmont Mining Corporation), an important precious metal producer, and 19.22% in Sociedad Minera Cerro Verde, an important Peruvian copper producer.
